## Party Contract

**Party Package Includes (\$300):** A \$35 fee will be added for parties with **more than 75 skaters** to provide additional floor guard coverage and ensure guest safety.

- 2 hours of skating fun
- paper products: (napkins and plates)
- skates
- child's name displayed on the marquee
- Music and Special Announcements

### Party Timing and Clean-Up

- Doors will open 10 minutes prior to the scheduled party time.
- To help us prepare for the next event, the party host is asked to assist in ensuring that all guests exit the building within **15 minutes of the party's conclusion**.
- The party host is responsible for making sure tables are cleared of all **drinks, food, and paper**, and that **all belongings are collected** before leaving the facility.

### Food & Beverage Policy (*Snack Counter Always Open*)

- **No outside food or beverage permitted including water.**
- **NO CAKE OR CUPCAKES**
- Goodie bags are **ONLY** allowed in the lobby. They may be distributed to your guests at the end of the party as guests are exiting the facility. Treats **MUST** be individually wrapped or in an individual sealed bag prior to entering the building. **Items not individually wrapped will not be permitted in the facility.**

### Optional Party Combo Vouchers

- Hotdog and Drink Combo Voucher \$2.25 per person.
- Pizza Slice and Drink Combo Voucher \$2.25 per person (requires whole pie purchase)
- Drink Voucher \$1.00 per person

### Skate & Facility Policy

- Personal skates may be used but they must be hand carried in and out of the building.
- All personal skates must be inspected prior to use and meet the following safety standards to ensure the safety of other skaters and facility floors:
  - ❖ no protruding axles
  - ❖ no missing parts
  - ❖ no visible dirt or grime

### Payment Terms

- A non-refundable deposit of **\$150.00** is required at time of booking to secure your party.
- The remaining balance is due on the day of the party if not paid in full prior to the event.
- We accept all major credit cards for payment. Please note that a **3%** processing fee will be applied to credit card transactions.
- **Personal Checks are not accepted for payment.**
